NOTIFICATION

S.O. _____ In exercise of the powers conferred by sub-section (2) of the section 11 of the Indian Medical Council Act, 1956(102 of 1956), the Central Government, after consulting the Medical Council of India, hereby makes the following further amendments in the First Schedule to the said Act:

(b) against "**Rajiv Gandhi University of Health Sciences, Bangalore, Karnataka**" and under the heading 'Recognized Medical Qualification' [Hereinafter referred to as column (2)], after the last entry and entry relating thereto under the heading 'Abbreviation for Registration' [Hereinafter referred to as column (3)], the following shall be inserted, namely:-



Sharma University of Health Sciences, Rohtak, Haryana" and under the heading 'Recognized Medical Qualification' [Hereinafter referred to as column (2)], after the last entry and entry relating thereto under the heading 'Abbreviation for Registration' [Hereinafter referred to as column (3)], the following shall be inserted, namely:-



"Bachelor of Medicine and Bachelor of Surgery" M.B.B.S.
(This shall be a recognized medical qualification when granted by Pt. B.D. Sharma University of Health Sciences, Rohtak, Haryana in respect of students being trained at ESIC Medical College, Faridabad on or after, December, 2019.

Note:-

1. The recognition so granted shall be for a maximum period of 05 years from the date of Notification upon which it shall have to be renewed.
2. The procedure for 'Renewal' of recognition shall be same as applicable for the award for recognition.
3. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate courses.
