Subject: Extension of two years to carry out internship by Foreign Medical Graduates in Non-Teaching Hospitals.

This is in continuation of earlier Circular No.U.15024/01/2022-UGMEB dated 09.05.2023 wherein it was informed that UGMEB validated the list of recognised non-teaching hospitals for Compulsory Rotating Medical Internship issued by the erstwhile Medical Council of India, for a period of one year i.e. upto May 2024 for conduct of internship for Foreign Medical Graduates only.

2. On the basis of various representations received from Medical Councils and FMGs regarding facing difficulties in deployment of FMGs for internship, **it has now been decided to extend the above time period from May 2024 to May 2026 i.e. for two years**. List of Recognised Non-teaching Hospitals for Compulsory Rotating Medical Internship issued by the erstwhile Medical Council of India is available in the NMC website Circular number mentioned above dated 09.05.2023.

PUBLIC NOTICE

This is in continuation to the Circular No. U.15024/01/2022-UGMEB dated 9th May 2023, uploaded by UGMEB regarding the conduct of internships for Foreign Medical Graduates (FMGs) which pertains to the provision of supplementing online classes with offline mode as mentioned in clause (x) of point 3 on page 3 of the above circular.

2 It has been observed that many FMGs are maliciously obtaining compensatory certificates from their parent universities for the online classes carried by them. The medical profession deals with precious human life, therefore the life of Indian citizens cannot be put at stake of poorly trained medical professionals. The UGMEB has decided that henceforth, <u>Certificate regarding the</u> <u>compensation/supplementation of online theory</u> <u>subjects/classes with offline practical and clinical training</u> <u>shall not be accepted.</u>

3. FMGs who have attended their classes online for any duration during their course completion are required to qualify the FMG Examination and subsequently undergo a Compulsory Rotating Medical Internship (CRMI) for a period of two/three years (a schedule of 12 months to be repeated) as mentioned in the Circular dated 9.5.2023 and as per the public notice uploaded on 7th December 2023.

4. This public notice is effective from the date of its publication.

Attention is invited to section 13.1.2 of "Registration of Medical Practitioners and Licence to Practice Medicine Regulations, 2023" and this office advisory of even number dated 23.08.2023 on the above subject (copy enclosed) vide which Sponsors of Temporary Registration was requested to ensure that the details of Fellowship programs being run by registered hospital/medical college/institute should be duly uploaded on their official website, along with information related to course content, duration, training facilities, teaching, faculty details (along with active registration No), infrastructure facilities and fee being charged by the Institute etc.

2. Despite the clear instructions, it has been observed that some of the registered hospital/medical college/institute have yet not uploaded the desired information on their website. This shortfall on the part of the Sponsors results in undue correspondence and avoidable delay in issuance of TP to the applicants.

3. In view of the above, in order to streamline the process of timely grant of temporary Registration to Foreign Medical practitioners, the Sponsors of Temporary Registration are once again requested to ensure, before submitting application of Temporary registration to National Medical Commission, that all the necessary details are available on the website of registered hospital/medical college/institute, for online verification by EMRB, National Medical

Commission while processing of applications for temporary registration.

4. Failure to comply with the above may cause delay in processing the applications received for temporary registration for fellowship programs and may also be a reason for rejection of application also and onus of such rejection would squarely lie with the Sponsoring institute.

Subject: <u>Processing of application of Temporary Registration to the foreign medical</u> practitioners sponsored by any Institute/Hospital in the country- regarding

In this respect, kind attention is invited to the sub-section 13.1.2 of Section 13 under chapter-IV (Fellowship/Clinical Research/Clinical Training/Observership etc.) of "Registration of Medical Practitioners and Licence to Practice Medicine Regulation 2023. In this regard it may be ensure by the sponsoring registered hospital/medical college/institute inviting foreign national for fellowship programs the following provision have been made in the said regulation:

"i. A foreign citizen may be allowed to do Fellowship/Clinical Research/Clinical training / Observership for enhancing their skill and competence through training or academic courses conducted in any Institute in India, ii. For the purpose, the Institute may apply to the Ethics and Medical Registration Board through the web portal along with the following details: a) Name and registration certification of the foreign citizen (if applicable) b) Information related to course content, duration, training facilities, teaching, and infrastructure facilities (details should be available on the website of the Institute) c) Details of fee being charged by the Institute....."

3. In view of the above in order to streamline the process of timely grant of temporary Registration to Foreign Medical practitioners the following should be ensured:

The details of Fellowship programs being run by such registered hospital/medical college/institute should be duly uploaded on their official website. along with information related to course content, duration, training facilities, teaching, faculty details (along with active registration No) and infrastructure facilities etc. must be made available for online verification of the same by EMRB (NMC) at the time of processing the application received for grant of Temporary Registration.

4. Failure to comply with the above may cause delay in processing the applications received for temporary registration for fellowship programs. Ordinarily, temporary registration in respect of the foreign medical practitioners which shall be provided for a maximum period of twelve (12) months followed by a cooling off period of one year and shall be limited to the medical college/institution/hospital sponsoring the programme.

Subject: Advisory/alert for Indian students seeking admission in foreign institutes/Universities for Undergraduate Medical Courses - reg.

Reference is invited to Public Notice of even number dated 08.08.2023 on the above cited subject. It has come to the notice of this Commission that in spite of Advisory and Alert issued by NMC, several Indian students are seeking admission to private medical colleges abroad which do not adhere to regulations laid by National Medical Commission and the Institutes or Universities abroad are following the curriculum, time frame and training imparted to the students are not in consonance with NMC regulations being followed in India. It has also come to the notice of this Commission that many students still taking admissions to such Institutes/Universities.

2. National Medical Commission published Foreign Medical Graduate Licentiates (FMGL) Regulations, 2021 in the official gazette of India vide notification dated 18.11.2021 wherein the terms of duration of the study, medium of instructions, syllabus, clinical training or internship/clerkship etc. are prescribed. These conditions are mandatory for registration to practice allopathy in India.

3. In view of the above, all the students who are desirous to obtain the medical qualification from any foreign medical institutions or universities and thereafter practice allopathy in India, are hereby again advised to ensure that all conditions prescribed in FMGL are

fulfilled before taking admission.

4. Any variation in duration, medium of instructions, syllabus, clinical training or internship/clerkship may lead to disqualification in grant of registration in India. In case of disqualification, the sole responsibility shall lie upon the candidate only.
