Colleges for 1st year MBBS degree for the Academic Year 2022-23 Reg.

Madam/Sir,

Kindly refer to the NMC circular of even number dated 20/12/2022 directing all medical colleges to fill up online details/data of students enrolled for 1st year MBBS degree for the academic year 2022-23. The last date for uploading said data was initially fixed as 31/12/2022, which was subsequently extended upto 10.01.2023. Despite giving sufficient time your medical colleges have not yet uploaded the data/details of the students enrolled for MBBS degree for academic year 2022-23. Non-uploading of data on the online format may entail difficulties in future.

Thus, as a onetime measure the date of uploading said data in the NMC portal is once again extended till 16.01.2023. You are, therefore, requested to upload data/details in respect of all the students enrolled for the MBBS degree by your medical colleges by the target date i.e. **16th January, 2023** on priority basis. In case the data is not uploaded by the target date, the concerned colleges will be held responsible for any litigation or complication arises at a later stage.

It is also emphasized that the terms, condition and guidelines issued vide letter of even number dated 20/12/2022. (Copy enclosed) as well as provisions of IMC Act, 1956 and National Medical Commission Act, 2019 are vigorously followed in admissions and uploading above data.
