(iii) The last date for grant of Letter of Permission for establishment of Medical Colleges as well as increase in intake capacity of existing Medical College/Renewal of Permission under section 10A of the IMC Act, 1956, in respect of MBBS course for the academic session 2020-21, from 31.5.2020 to 31.8.2020.

2. The commencement of academic session of PG Courses (Broad Specialty) for this year only shall be from 1st July 2020 with 31st July 2020, as the last date of admission for the academic session, accordingly.

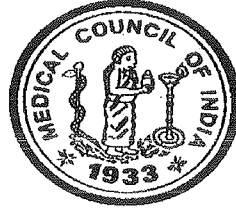
