Reference is invited to the Public Notice of even number dated **01.11.2024** and subsequent communications regarding uploading of Annual Declaration details/data by respective medical colleges/institutions on the **NMC Portal**, as mandated under the **NMC Act, 2019** and relevant regulations issued by the Commission from time to time.

2. The process of assessment for annual renewal of all medical colleges recognized by NMC is currently underway. However, it has been **observed that certain colleges have not filled in the required details related to cadavers** under the heading '**Clinical Load – Anatomy Department**'. Kindly note that the information related to **number of cadavers handled** by each medical college is **mandatory information**.

3. Additionally, **all medical colleges/institutes** are required to provide the following details in the **Annual Declaration Form**:

- a. Number of **Major Operation Theatres (OTs)**
- b. Number of **Minor Operation Theatres (OTs)**

The relevant fields to submit this information have been created under the heading '**Hospital Details**' in the Annual Declaration Form.

4. To facilitate submission of the above details, the **NMC Portal will remain open from 25.04.2025 to 28.04.2025**. The concerned medical colleges/institutes are hereby informed to furnish all the above information within the stipulated time.
