1. Minutes of the last meeting of the Ethics Committee- Confirmation of.

2. Action taken on the previous minutes presented before the Ethics Committee on 17.07.2012.

The Ethics Committee noted action taken on the minutes of the Ethics Committee held on 17.07.2012 pertaining to the hearing cases.

3. Appeal against order dated 10.02.2012 passed by U.P. Medical Council made by Sh. Ram Murty Garg against Dr. R.C. Mishra & Dr. Muneeshwar Gupta. (F.No. 318/2011)

The Ethics Committee considered the appeal against order dated 10.02.2012 passed by U.P. Medical Council filed by Sh. Ram Murty Garg against Dr. R.C. Mishra & Dr. Muneeshwar Gupta and decided to call all the concerned parties at its next meeting of the Ethics Committee.

4. RC 34(A)/2010 of CBI, ACB, Chennai - MCI case - Charge sheet (against Shri M.K. Rajagopalan, Chairman, Sri Balaji Educational & Charitable Public Trust, Chennai and Dr. D.R. Gunasekaran, Vice Chancellor, Sri Balaji Vidyapeeth, Deemed University, Pondicherry.

The Committee perused the papers and was of the view that this item required detailed discussion, hence, deferred to next meeting.

5. Appeal against order dated 28.09.2010 passed by Delhi Medical Council made by Mr. Narinder Kumar (F.No. 839/2010).

The Committee perused the papers and was of the view that this item required detailed discussion, hence, deferred to next meeting.

6. **Appeal against order dated 02.06.2011 passed by Karnataka Medical Council filed by Sh. Pankaj Rai (F. No. 102/2011).**

The Committee perused the papers and was of the view that this item required detailed discussion, hence, deferred to next meeting.

7. **Appeal against order dated 26.10.2007 passed by Rajasthan Medical Council filed by Mr. Ajeet Singh Singhvi.(F.No. 277/2007)**

The Committee perused the papers and was of the view that this item required detailed discussion, hence, deferred to next meeting.

8. **Appeal against order dated 07.06.2010 passed by Delhi Medical Council made by Mr. S.P.Manchanda.(F.No.597/2010).**

The Ethics Committee considered the appeal against order dated 07.06.2010 passed by Delhi Medical Council made by Mr. S.P.Manchanda and noted that Dr. Alka Gupta and Dr. Navita Kumari had been asked to appear before the Ethics Committee and they were present before the Committee alongwith their advocate. Detailed hearing was given to them and they made oral as well as written submission before the Ethics Committee. Mr. S.P. Manchanda was also present heard in person. The Ethics Committee also noted that Dr. Pooja Bhatia & Dr. Vikas (Anaesthetist) were not present. Their counsel sought an adjournment on the grounds that they have made a representation to the Board of Governors. The Ethics Committee informed the concerned advocate that he should ensure that the said doctors are present before 5.30 p.m. today evening. However, the said doctors failed to appear before the Ethics Committee. Even in the last two hearing the said doctors did not appear personally despite notice to that effect. In these circumstances, the Ethics Committee decided to give one final opportunity to the said doctors to appear in person in the next date of the hearing before the Ethics Committee.

9. **Complaint against Dr. Deepak Tyagi, Dr. Chetan Goel & Dr. Vikas Ragve of IVY Hospital, Mohali (Punjab) as alleged by Mr. Om Prakash Sikka. (F.No. 209/2009).**

The Ethics Committee considered the complaint against Dr. Deepak Tyagi, Dr. Chetan Goel & Dr. Vikas Ragve of IVY Hospital, Mohali (Punjab) as alleged by Mr. Om Prakash Sikka and heard both complainant and the treating doctors at length. The records available alongwith expert committee report received from PGI Chandigarh was examined. It was thereafter unanimously felt that standard protocol for management of patient with head injury suffering from Sub Dural Haemtoma (SDH) with mid line shift and brain Oedema had been followed in this case. Therefore no professional misconduct on the treating team was found in the instance case. The complaint is disposed of.

10. **Appeals by Sh. Ramesh Kumar Khatri Numbardar against(1) Order dated 30.12.2011 passed by Delhi Medical Council (DMC) (2) Order passed by Haryana State Medical and Dental Council (HSMDC) dated 12.10.2011 and against (3) DMC for referring the complaint to HSMDC and no action by both Councils.**

The Ethics Committee considered the appeals by Sh. Ramesh Kumar Khatri Numbardar against (1) Order dated 30.12.2011 passed by Delhi Medical Council (DMC) (2) Order passed by Haryana State Medical and Dental Council (HSMDC) dated 12.10.2011 and against (3) DMC for referring the complaint to HSMDC and no action by both Councils and directed the counsel of the appellant to supply copies of all the appeal to the respondent /their counsel filed by him before the Medical Council of India alongwith all documents by 28th September, 2012 as the same has not been provided to respondent /their counsel.

All the respondent/concerned parties to file their reply within 4 weeks from receipt of the appeal alongwith all the documents.

The representatives from Sir Ganga Ram Hospital & Bharat Blood Bank, Panipat to file their replies also within 4 weeks alongwith documents if any.

The matter may be placed before the Ethics Committee at its subsequent meeting.

11. Complaint against Dr. R. P. Singh, Eye Surgeon as alleged by Mr. P.C.Jain - F.No. 78(2010).

The Ethics Committee considered the complaint of Mr. P.C. Jain against Dr. R.P. Singh, Eye Surgeon. The counsel for the respondent of Dr. R.P. Singh stated that he has received the copy of the complaint and other documents supplied to him today. He also stated that he will file his reply alongwith supportive documents within 3 weeks time. Hearing notices to be sent to all concerned parties. Dr. R.P. Singh to be informed to personally appear at the next date of the hearing.

12. Appeal against order dated 18.11.2011 passed by Uttar Pradesh Medical Council filed by Sh. Ghulam Abbas against Dr. Aroti Ghosh (F.No.431/2011) 02:30 PM

The Ethics Committee considered the appeal against order dated 18.11.2011 passed by Uttar Pradesh Medical Council filed by Sh. Ghulam Abbas against Dr. Aroti Ghosh and noted that despite notices sent to the respondent Dr. Aroti Ghosh, she did not appear before the Ethics Committee. She had failed to appear before the Ethics Committee at its previous meetings also. It was clearly stated in the last notice directing Dr. Aroti Ghosh to appear before the Ethics Committee on 22.09.2012, failing which the matter will be decided ex-parte. The Ethics Committee further noted that Mr. Gulam Abbas appeared before the Ethics Committee and heard at length.

The Ethics Committee noted that Dr. Aroti Ghosh did not provide adequate care to Mrs. Ghulam Abbas during her anti natal period and during labour. Her nursing home was not adequately equipped with basic support systems essential for management of patient in high risk labour. She also failed to refer the patient in time to appropriate hospital that was available. The matter be referred to one of the member of the Ethics Committee for expert opinion for the Committee to take a final decision.

13. Appeal against order dated 27.07.2011 passed by Delhi Medical Council made by Dr. Bhupendra Nath Singh (F.No. 407/2011) 03:00 PM

The Ethics Committee considered the appeal filed by Dr. Bhupendra Nath Singh and noted that the Ethics Committee had asked Dr. Vishal Sharma - Casualty Medical Officer & Dr. Sunil K Khetarpal - Medical Superintendent, Indian Spinal Injury Centre to appear before the Ethics Committee but they did not turn up. The Ethics Committee further noted that Mr. U.K. Sinha has also filed an appeal against the decision of the Delhi Medical Council. Copy of the appeal has been sent to Dr. Bhupendra Nath Singh, he may file reply within 2 weeks alongwith other documents. The Ethics Committee heard Dr. Bhupendra Nath Singh & Mr. U.K. Sinha at length.

After verifying/determining the current addresses of the concerned doctors from Indian Spinal Injury Centre, final notice to be sent to Dr. Vishal Sharma - Casualty Medical Officer & Dr. Sunil K Khetarpal - Medical Superintendent, Indian Spinal Injury Centre and to Mr. U.K Sinha to appear before the Ethics Committee at its subsequent meeting.

14. Complaint against Dr. Rakesh Varma, HOD , Cardiology, Safdarjung Hospital, New Delhi- Review of recommendations of Ethics Committee of Medical Council of India. (F.No. 396/2009).

The Committee perused the papers and was of the view that this item required detailed discussion, hence, deferred to next meeting.

15. Appeal against order dated 06.09.2011 passed by Karnataka Medical Council made by Ch. Shankaraiah against Dr. Kiran J. (F.No. 535/2011).

The Committee perused the papers and was of the view that this item required detailed discussion, hence, deferred to next meeting.

16. Violation of "Indian Medical Council (Professional Conduct, Etiquette and Ethics) Regulations, 2002" - Reg. (Sh. Brinda Karat, Member, Polit Bureau, CPI(M), Former Member, Rajya Sabha) (F.No. 615/2011).

The Committee perused the papers and was of the view that this item required detailed discussion, hence, deferred to next meeting.

17. Suspension/cancellation of medical licenses of doctors convicted under the PC & PNDT Act.

The Council had received an email dated 30.08.2012 from Ms. Anuradha Vemuri, Director, Ministry of Health and Family Welfare, Nirman Bhawan, New Delhi enclosing therein letter dated 22nd June, 2012 from Ms. Anuradha Gupta, Additional Secretary and Mission Director, NRHM and another letter dated 16th May, 2012 from Sh. Manoj Jhalani, Joint Secretary, Ministry of Health and Family Welfare, New Delhi. In the said communications, the Central Supervisory Board, chaired by the Union Health Minister, considered the matter of suspension/cancellation of medical license of doctors convicted under the PC & PNDT Act and directed the Council to take immediate steps against the names of the convicted doctors (list provided) under the said Act.

Accordingly this Council issued appropriate communication dated 04.09.2012 to concerned state medical Council towards ensuring the decision above is implemented in the right earnest. The details of punishment awarded to doctors is as under:-
