- 2. Pathological post-mortems are still not performed in the institute.
- 3. Frozen Section, Histochemistry, Immunohistochemistry are not available.
- 4. Workload of Bone Marrow Biopsy is only 1 till November 2015 which is inadequate.
- 5. License for Blood Component Separation facility is not available and equipment cannot be used without license.
- 6. Other deficiencies as pointed out in the Assessment Report.

In view of the above, the Postgraduate Medical Education Committee decided to return the application to the Central Government recommending disapproval of the scheme for Starting of MD(Pathology) course at ICARE Institute of Medical Sciences & Research, Haldia, Purba Midanpore, West Bengal under West Bengal University of Health Sciences, Kolkata u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

5. Starting of MD(Community Medicine) course at ICARE Institute of Medical Sciences & Research, Haldia, Purba Midanpore, West Bengal under West Bengal University of Health Sciences, Kolkata u/s 10A of the IMC Act, 1956 for the academic year 2016-17 - consideration of compliance verification assessment report.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (03rd December 2015) along with the Council Assessor's Report (24th & 25th August 2015) and compliance dated 07th November 2015 submitted by the college authorities and noted the following:

- 1. RHTC is still under administrative control of the State Govt. & not under Dean.
- 2. PHC Amlat was visited personally & as per statement of M.O., Amlat, no doctor from the institute ever visited PHC Amlat.
- 3. UHC is still under control of Haldia Municipality & not under Dean.
- 4. On day of assessment, there was only 1 patient in UHC, although 34 patients were entered in register.
- 5. In ANC register, entries of cases from 01/01/2015 were made by hand in one handwriting using only 1 pen.
- Space in the department is inadequate. Temporary arrangements made for Research Laboratory are inadequate. Equipment for PG laboratory or Research laboratory are inadequate.
- 7. Deficiency of Tutors: 2 still exists.
- 8. Departmental infrastructure is inadequate even for UG training.
- 9. Visit to O.T. at 02:30 p.m. revealed that all O.T.s were without surgeries.
- 10. Pharmacy computer could show only a few medicines dispensed on day of assessment & on previous few days which does not match with claimed OPD attendance.
- 11. Many wards were empty & Bed occupancy figure of 80% does not match with actual IPD observed.
- 12. LMO is not on staff strength of the department but is working in the hospital. One LMO was posted at UHC only on day of assessment.
- 13. Not a single subject related journal was available in library. Books in Central & Departmental library are inadequate.
- 14. Other deficiencies as pointed out in the Assessment Report.

- 4. Only 2 faculty were present in Unit I on day of assessment; hence it cannot be considered as PG Unit.
- 5. No faculty was present in Unit II on day of assessment.
- 6. Only 1 out 4 Senior Residents was present on day of assessment; resultantly there is deficiency of 1 Senior Resident.
- 7. Faculty deficiency: Assoc. Professor-1; Asst. Professor-3 and Senior Resident-1.
- 8. Other deficiencies as pointed out in the Assessment Report.

In view of the above, the Postgraduate Medical Education Committee decided to return the application to the Central Government recommending disapproval of the scheme for Starting of MD(Paediatrics) course at Azeezia Instt of Medical Science, Meeyannoor, Kollam, Kerala under Kerala University of Health Sciences, Thrissur u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

- 2. Dr. S.D.S Rawat, Professor & HOD possesses experience of only 7 years 5 months in Army teaching hospitals before being appointed as Professor; hence not eligible for the post of Professor. He had supplied wrong information earlier that he was Senior Advisor from 2009 to 2012.
- 3. There is no other Professor in the department; resultantly there would be deficiency of faculty: (a) Professor: 1.
- 4. Other deficiencies as pointed out in the Assessment Report.

In view of the above, the Postgraduate Medical Education Committee decided to return the application to the Central Government recommending disapproval of the scheme for Increase of seats in MD(DVL) course at Himalayan Institute of Medical Sciences, Dehradun, Uttrakhand under Swami Rama Himalyan University, Dehradun u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

The Committee further decided to refer the matter to the Ethics Committee.

- 3. Lecturer cum Medical officer for RHTC/UHC are not available.
- 4. In RHTC there were 2 patients in IPD and no delivery on assessment day, which is inadequate clinical material.
- 5. Cold chain equipment at UHTC inadequate. For ILR purchase order placed, not yet installed.
- 6. Other deficiencies as pointed out in the Assessment Report.

- 9. Data of Major Operations for last year has been changed. Major Operations 608, Minor Operation 2278, total 2886. This is excluding 201 day care operations. Even with this data total operations (2286) are 3 times the total IPD (860), which is not feasible. When there is a separate column for day care surgeries, minor operations cannot be considered as done on OPD basis.
- 10. Dr. Vikram Parmar promoted Assoc. Professor on 01/08/2015. One out of two publications quoted is general article and cannot be accepted. Hence, his promotion is not as per Regulations.

Read: the Council Assessor's Report (May, 2015) and compliance dated 31/08/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MD(Physiology) qualification for 2 seats at Jawaharlal Nehru Medical College, Bhagalpur granted by Aryabhatta Knowledge University, Patna.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (May, 2015) and compliance dated 31/08/2015 submitted by the college authorities and decided to recommend not to recognize MD(Physiology) qualification for 2 seats granted by Aryabhatta Knowledge University, Patna in respect of students being trained at Jawaharlal Nehru Medical College, Bhagalpur because of the following facts:-

Compliance is not satisfactory.

- 1. Deficiency of faculty of (a) Asso. Prof.: 1; (b) Tutor: 1 remains as such. No new appointments have been made.
- 2. There is only research publication from the department in indexed journals in last 3 years. Articles which have been submitted cannot be considered unless they are accepted.
- 3. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. 02 seats after the first batch appeared in Examination till their recognition will be irregular/illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."

In case, the college authorities desire to submit compliance, same should be received in this office preferably within six weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

- 4. Dr. Seema Mittal with DNB qualification from non-teaching institution is not eligible to be appointed as Senior Resident ab-initio. She had no 3 years experience at the time of appointment as Senior Resident. Resultantly, she is not eligible to be appointed as Senior Resident.

- 6. Other deficiencies as pointed out in the Assessment Report.

In view of the above, the Postgraduate Medical Education Committee decided to return the application to the Central Government recommending disapproval of the scheme for Increase of seats in MS (ENT) course at M.S. Ramaiah Medical College, Bangalore under Rajiv Gandhi University of Health Sciences, Karnataka u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

84. Increase of seats in MD (DVL) course at RajaRajeswari Medical College & Hospital, Bangalore under Rajiv Gandhi University of Health Sciences, Karnataka u/s 10A of the IMC Act, 1956 for the academic year 2016-17 consideration of compliance verification assessment report.

Read: the Compliance Verification Assessment Report (18.09.2015) along with the Council Assessor's Report (March, 2015) and compliance dated 17/12/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of MS(OBG) qualification against increased intake from 04 to 06 seats at Smt. B.K. Shah Medical Institute & Research Centre, Vadodara granted by Sumandeep Vidyapeeth, Vadodara.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (18.09.2015) along with the Council Assessor's Report (March, 2015) and compliance dated 17/12/2015 submitted by the college authorities and decided to verify compliance by way of Assessment.

89. <u>Saurashtra University, University Road, Rajkot - Renewal of recognition of M.D.(Pharmacology) qualification for 02 seats in respect of students being trained at C.U.Shah Medical College & Hospital, Surendranagar.</u>

Read: the Compliance Verification Assessment Report (06.10.2015) along with the Council Assessor's Report (April, 2014) and compliance dated 10/12/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Renewal of recognition of M.D.(Pharmacology) qualification for 02 seats at C.U.Shah Medical College & Hospital, Surendranagar granted by Saurashtra University, University Road, Rajkot.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (06.10.2015) along with the Council Assessor's Report (April, 2014) and compliance dated 10/12/2015 submitted by the college authorities and decided to recommend to the Central Government that the recognition of M.D.(Pharmacology) qualification for 02 seats granted by Saurashtra University, University Road, Rajkot in respect of students being trained at C.U.Shah Medical College & Hospital, Surendranagar be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

Read: the Compliance Verification Assessment Report (12.12.2014) along with the Council Assessor's Report (July, 2013) and compliance dated 01/12/2015 & 05/012/2015 submitted by the college authorities on the standard of examination and other teaching facilities for Recognition of M.Ch.(CTVS) qualification against increased intake from 02(Two) to 04(Four) seats at Postgraduate Institute of Medical Education and Research, Dr. R. M. L. Hospital, New Delhi granted by Guru Gobind Singh Indraprastha University, New Delhi.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (12.12.2014) along with the Council Assessor's Report (July, 2013) and compliance dated 01/12/2015 & 05/012/2015 submitted by the college authorities and decided to recommend not to recognize M.Ch.(CTVS) qualification against increased intake from 02(Two) to 04(Four) seats granted by Guru Gobind Singh Indraprastha University, New Delhi in respect of students being trained at Postgraduate Institute of Medical Education and Research, Dr. R. M. L. Hospital, New Delhi because of the following facts:-

1. As per reply given by Registrar, Postgraduate Institute of Medical Education and Research, Dr. R. M. L. Hospital, New Delhi, Dr. V.K. Gupta joined CGHS in 1998 and was posted in CTVS department of RML Hospital. He completed 60 years in 2014. It is for the Institution to redesignate him and issue fresh orders, his joining report and declaration form. If he wants to claim benefit of previous experience at other institutions (which has already been rejected) based on some new facts he should submit experience certificate from competent authorities of only those institutions along with proof that they are running MCI recognized M.Ch. course in CTVS department.

- 2. In the assessment reports of both, December, 2014 and July, 2013, in the faculty table signed by the Dean and Assessor, Dr. Vijay Grover was shown as Senior Research Associate from 1998 to 2001, which cannot be accepted. He did not have the requisite experience as required under the regulations and the University could not have given him the teaching designation under the prevelant regulations.
- 3. Other deficiencies as pointed out in the Assessment Report.

Admissions done (if any) against these seats i.e. increased intake from 2 to 4 seats after the first batch appeared in Examination till their recognition will be irregular/illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."

In case, the college authorities desire to submit compliance, same should be received in this office preferably within six weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

- 3. Promotion of Dr. Femela, Assoc. Professor is not as per Regulations. She has no two publications during her period of Asst. Professorship. One of the publications is outside the period of promotion.

- 4. The publications submitted by Dr. Sushma Nair are only review articles published in Chettinad Health City Medical Journal, which cannot be accepted.
- 5. Other deficiencies as pointed out in the Assessment Report.

In view of the above, the Postgraduate Medical Education Committee decided to return the application to the Central Government recommending disapproval of the scheme for Increase of seats in MD(Pathology) course at Chettinad Hospital & Research Institute, Kanchipuram, Tamilnadu under Chettinad Academy of Research and Education (Deemed University) u/s 10A of the IMC Act, 1956 for the academic year 2016-17.

92. Increase of seats in MS(General Surgery) course at Chettinad Hospital & Research Institute, Kanchipuram, Tamilnadu under Chettinad Academy of Research and Education (Deemed University) u/s 10A of the IMC Act, 1956 for the academic year 2016-17 - consideration of compliance verification assessment report.

- 6. Postgraduate Degree of Dr. Premlata, Professor, Unit-II is not recognized.
- 7. Dr. Karuna Nidhi, Professor was absent on the day of Assessment. Resultantly, Unit-III left with 2 faculty and it cannot be considered a teaching Unit.
- 8. Other deficiencies as pointed out in the Assessment Report.

Professor from 15/06/2010 to 30/06/2014 without offering any explanation for the same, which amounts to providing misleading information to the Council.
- 3. Treatment for MDR Tuberculosis is not available. It is only stated that "Treatment as per RNTPC norms treatment is facilitated" which does not imply that treatment for MDR Tuberculosis is available.
- 4. Other deficiencies as pointed out in the Assessment Report.

Hence, her promotion is not as per Regulations.
- 9. Promotion of Dr. Gurneesh, Assoc. Professor is not as per Regulations. He was Asst. Professor for 4 years 3 months (December, 1997 to January, 2001 and August, 2012 to September, 2013). During this period he has only one publication SI. No. 1.) All others are outside his period of Asst. Professorship and they cannot be accepted.
- 10. Other deficiencies as pointed out in the Assessment Report.

- 3. Facilities of Retinal Surgery are not available. MOU with private hospital cannot be accepted in lieu thereof.

Hence, it cannot be a clerical error. While hospital census is attached in Annexure I, it has not specifically been shown how the beds are increased physically to 30 beds. To that extent deficiency is not rectified.
- 3. Other deficiencies as pointed out in the Assessment Report.
