- 1. Equipment like HPLC is not available.
- 2. Pathological post-mortems are not performed. Contention of the Institute that "Postmortems are not permitted in the college" is not relevant as it pertains to Medico-legal postmortems and not to Pathological postmortems which are for academic purposes only.
- 3. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. 1 seat after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. - 2. Dr. Roopa Devi Hosamani, Dr. Vaseem Ali & Dr. Sweta D.K., all 3 Sr. Resident are DNB from non-teaching hospital. They have no 3 years experience in a teaching hospital when appointed as Sr. Resident. Hence they are not eligible. Resultantly, there is deficiency of Sr. Resident. -2.

- 4. Dr. Susan Mathen, Sr. Resident is not available, she was appointed 01.09.2017 and she is not MD.
- 5. Promotion of Dr. Lal Bahadur Palo, Prof., is not as per regulations. He was promoted on 11.03.2017 after the cut off date. All 4 publications quoted are of general nature and not research articles related to speciality.
- 6. Total Delivery was only 1 on day of assessment.
- 7. There were only 2 Major Operations on day of assessment and there was only one caesarian section.
- 8. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. 2 seats till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. - 1. Dr. Aruna C. Ramesh is shown under training abroad in Emergency Medicine during the period from 1999 to 2000; however in the faculty table, she is shown to have worked as Asst. Prof. from 02/05/1997 to 30/10/2000 which is not feasible and is an attempt to mislead the Council. Further, she is transferred to Emergency Medicine as Professor from the post of Professor of Anaesthesiology without any teaching experience in Emergency Medicine as such; in view of these facts, she cannot be considered.
- 2. Dr. T.S. Deepak is shown to be under training in Emergency Medicine from 01/01/2007 to 31/12/2008; however in the faculty table, this period is included within the period shown as Asst. Prof. of Anaesthesiology which is not permissible and is an attempt to mislead the Council. Further, he is promoted as Assoc. Prof. with experience of only 1 y 9 m in Emergency

Medicine against requirement of 5 y. In view of these facts, he cannot be considered.

- 3. Dr. V.R. Anil Kumar is shown to be under training in Emergency Medicine from 01/01/2007 to 31/12/2008; however in the faculty table, this period is included within the period shown as Asst. Prof. of General Surgery which is not permissible and is an attempt to mislead the Council. He is transferred to Emergency Medicine as Assoc. Prof. from the post of Assoc. Prof. of General Surgery without any teaching experience in Emergency Medicine as such. In view of these facts, he cannot be considered.
- 4. In the previous assessment report dt. 28/06/2017, it is shown that separate department of Emergency Medicine was established in 2008; however Dr. T.S. Deepak & Dr. V.R. Anil Kumar are shown to have received training in this department from 01/01/2007 to 31/12/2008 which is not feasible and is an attempt to mislead the Council.
- 5. Dr. Keshava Murthy M R , Asst.Prof. is shown Astt. Prof. in the column of designation and Sr. Resident in the column of experience, which is not feasible.
- 6. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. 2 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. Prof.: 2.
- 2. OPD on day of assessment is only 96 which is less than minimum required even to start PG course.
- 3. Bed Occupancy at 10 a.m. on day of assessment was 66.67 %.
- 4. There were only 1 Major, 2 Minor & 1 Daycare Operations on day of assessment which is grossly inadequate.
- 5. There was NIL Normal Delivery & only 1 Caesarean Section on day of assessment.
- 6. A few tests like Non Stress Test, Dressings, Stitch Removals, PAP Smears are shown as Minor Operations which is not correct as these are procedures & cannot be considered as Minor Operations.
- 7. Dr. Sadhna Sharma, Prof. & HoD, was absent on the day of assessment. There is no certificate of examination duty from any university.
- 8. Dr. Manju Kumar, Assoc.prof. was absent on the day of assessment.
- 9. No proper record of speciality clinics is maintained.
- 10. Dr. Patil Prashant Arun, Sr. Resident, is not eligible. He has no 3 years experience as Jr. Resident when appointed as Sr. Resident. There is no other Sr. Resident in the Unit-II.
- 11. Dr. Harikishan Kaur Khaira, Professor, Unit-III, was absent on the day of assessment.
- 12. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. 3 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. - 1. In respect of Dr. M.R. Raghavi, Dr. Jennier Britto, Dr. P. Surya & Dr. T. Puvithra, Senior Residents, deficiency of not having 3 years experience as Resident in a teaching Hospital remains as it is.
- 2. Dr. P. Surya, Sr.Resident, was not available on the day of assessment. There is no proof /certificate of maternity leave attached.

- 2. ART service is not available. Patients are referred to KGMU, Lucknow which is not permissible.
- 3. There are 3 units of 30 beds and maximum permitted seats can be 9. However, college has been admitting 18 students.
- 4. Promotion of Dr. Veena Gupta, Prof., is not as per regulations. She was promoted Professor on 09.05.2014 after cut off date.. She has only 2 publications against the required 4.
- 5. Dr. Urvashi Barman is shown Asst.Prof. in the column of designation and Assoc.Prof. in the column of experience, which is not feasible. She has no publications.
- 6. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. ----- after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. - 1. Deficiency of faculty: (a) Assoc. Prof.: 1.
- 2. Dr. Ashim Mandal, Senior Resident is not eligible. He is appointed Sr.Resident on 10/08/2017 & possesses only MBBS qualification.
- 3. Dr. Sudhir Kumar Banerjee, Senior Resident has experience of only 2 year as Resident before appointment as Senior Resident; hence not qualified to hold the post.
- 4. Promotion of Dr. Som Nath Dey, Assoc.Prof., is not as per regulations. He was Asst.Prof. for 4 years 8 months and he has no publication.
- 5. Experience of Dr. Bileshwar Mistry is shown as "Senior Resident" w.e.f. 05/05/2000 till date in the faculty table; however in the same table, in the column of "Remarks" it is stated that "He worked in the department of Anaesthesiology from 05/05/2010 to 29/03/2017 as JR" which is not feasible. No explanation is provided for this dichotomy.
- 6. Other deficiencies as pointed out in the assessment report.

- 3. Dr. Kalpita Patil, Senior Resident in Unit I does not have any experience as Resident before appointment as Senior Resident; hence not qualified to hold the post. There is no other Senior Resident in the Unit.
- 4. Total number of patients in OPD has decreased from 50,843 in 2015 to 48,837 in 2017.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (30/01/2018) along with the Council Assessor's Report (June, 2014 for 2 to 4 degree & 2 diploma seats and May, 2015 for 4 to 6 seats & 22.07.2015 for 2 to 4 degree & 2 diploma seats and 11.05.2016) and compliance dated 25/10/2016 submitted by the college authorities and decided to recommend not to recognize MD(Pathology) qualification against increased intake from 02 to 06 seats and DCP qualification for 02 seats granted by Padmashri Dr. D.Y. Patil University, Navi Mumbai in respect of students being trained at Padmashri Dr. D.Y.Patil Medical College, Navi Mumbai because of the following facts:-

- 1. Dr. Prakash Roplekar, Professor & HOD is promoted as Professor after cut-off date; however in the column of "Benefit of publications" in the faculty table, it is stated "No" implying NIL publication against requirement of 4; hence his promotion is not as per Regulations & he cannot be considered.
- 2. Workload of CT guided FNAC & TT is very low only 38 & 17 respectively in 2017.
- 3. Workload of CT guided FNAC was NIL & of USG guided FNAC only 1 on day of assessment.
- 4. Pathological post-mortems are not performed.

Patil University, Navi Mumbai in respect of students being trained at Padmashri Dr. D.Y.Patil Medical College, Navi Mumbai because of the following facts:-

- 1. There was only 1 Major Operation on the day of assessment.
- 2. During the last year, total number of Major Operations was only 321 implying daily average of < 1.
- 3. Workload of the following operations was NIL on day of assessment as well as on randomly selected days:
 - (a) Haemangiomas;
 - (b) Branchial Cysts/Sinuses;
 - (c) Repair of Omphalocoele.
- 4. There is only 1 publication from the department during last 3 years.

- 1. Workload of the following was NIL on day of assessment as well as on randomly selected days:
 - (a) Peripheral Angiograms & Procedures;
 - (b) Valvuloplasty/Umbrella Closure;
 - (c) PPC Implanted;
- 2. Workload of the following is very low during last year:
 - (a) Peripheral Angiograms & Procedures: 15;
 - (b) Intra-Aortic Balloon Pump Insertions: 15;
 - (c) PPM Implanted: 24;
 - (d) Valvuloplasty/Umbrella Closure: 36.
- 3. Attendance at Specialty clinic like Pacing clinic is low 2-4 cases/clinic.
- 4. No reference of any of the five publications quoted during last 3 years have been given without which they cannot be accepted as Research articles in indexed journals.
- 5. As per table 23 page no.8 college has admitted 3 students in 2017. However, as per table 8 on page no.15, no student was admitted in 2017. This discrepancy need to be explained.
- Independent deptt. Of cardiology was started on 25.3.2010. Dr. Shantanu Deshpandey, Assoc.Prof. has been shown to be working as Asstt.Prof. w.e.f. 15.4.2008 and Assoc.Prof. w.e.f. 1.7.2008 when the department was not in existence. This is not feasible.
- Independent deptt. Of Cardiology was started on 25.3.2010. Dr. Satish Vaidya, Assoc.Prof. has been shown to be working as Asstt.Prof. w.e.f. 1.8.2007, when the department was not in existence. This is not feasible.
- 8. Dr. Keshav Kale, Asstt.Prof. is DNB from non-teaching. He has no 3 years experience as JR in a teaching hospital when appointed ab-initio as SR and then Asstt.Prof. on 2.1.2018.
- 9. Dr. Somnath Mallakmir has been shown as Asstt.Prof. from 17.6.2005 to 9.8.2010 and Assoc.Prof. from 10.8.2010 to June 2014 and surprisingly he is shown Sr. Resident now from 1.8.2017 which is not logical and practical.
- 10. Dr. Amey Chavan is shown Asstt.Prof. from 5.4.2017 to 30.12.2017 and he has now been shown Sr. Resident from 1.1.2018 which is not logical and practical.

- 5. Dr. Kirtibala Dhande, Senior Resident does not have 3 y experience as Resident before appointment as Senior Resident; hence not qualified to hold the post.
- 6. Dr. Meghna Chaudhari, Sr. Resident, is not eligible. She is DNB from nonteaching and she has no 3 years experience as Jr. Resident when appointed Sr.Resident. Resultantly, there is a deficiency of Sr.Resident -4.
- 7. Faculty table is not signed by any faculty members.

Patil University, Navi Mumbai in respect of students being trained at Padmashri Dr. D.Y.Patil Medical College, Navi Mumbai because of the following facts:-

- 1. Dr. Amit Dhond is shown as "Assoc. Prof." in the column of "Designation"; however in the column of "Experience" he is shown as "Asst. Prof." w.e.f. 04/03/2015 till date. No explanation is provided for this dichotomy.
- 2. Dr. Arvind Vatkar, Asst.Prof. is not eligible. He was appointed on 20.09.2017. He has no one year experience as Sr. Resident after postgraduation. Resultantly, Unit-III left with only 2 faculty.
- 3. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. 2 seats till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. This is also clarified in the letter of recognition granted u/s 11(2) of the IMC Act, 1956 issued for these seats, which reads as under:

"...the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

Admissions done (if any) against these increased number of seats i.e. against increased intake from 05 to 08 seats (05 to 06 & 06 to 08) seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."

In case, the college authorities desire to submit compliance, same should be received in this office preferably within four weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

72. Padmashri Dr. D.Y. Patil University, Navi Mumbai - Renewal of recognition of MD(Radiodiagnosis) qualification for 1 seat in respect of students being trained at Padmashri Dr. D.Y.Patil Medical College, Navi Mumbai.

Read: the Compliance Verification Assessment Report(02.02.2018) and Council Assessor's Report (May, 2015 16.05.2016 & 10.04.2017) on the standard of examination and other teaching facilities for Renewal of recognition of MD(Radiodiagnosis) qualification for 1 seat at Padmashri Dr. D.Y.Patil Medical College, Navi Mumbai granted by Padmashri Dr. D.Y. Patil University, Navi Mumbai.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (02/02/2018) along with the Council Assessor's Report (May, 2015 16.05.2016 & 10.04.2017) and compliance dated Council received date 04/10/2017 submitted by the college authorities and decided to recommend to the Central Government that the recognition of MD(Radiodiagnosis) qualification for 1 seat granted by Padmashri Dr. D.Y. Patil University, Navi Mumbai in respect of students being trained at Padmashri Dr. D.Y.Patil Medical College, Navi Mumbai be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

73. <u>Padmashri Dr. D.Y. Patil University</u>, Navi Mumbai - Recognition of <u>MD(Emergency Medicine)</u> qualification for 2 seats in respect of students being trained at Padmashri Dr. D.Y.Patil Medical College, Navi Mumbai.

Read: the Compliance Verification Assessment Report(08.02.2018) and Council Assessor's Report (May, 2015) on the standard of examination and other teaching facilities for Recognition of MD(Emergency Medicine) qualification for 2 seats at Padmashri Dr. D.Y.Patil Medical College, Navi Mumbai granted by Padmashri Dr. D.Y. Patil University, Navi Mumbai.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (08/02/2018) along with the Council Assessor's Report (May, 2015) and compliance dated 10/05/2016 submitted by the college authorities and decided to recommend not to recognize MD(Emergency Medicine) qualification for 2 seats granted by Padmashri Dr. D.Y. Patil University, Navi Mumbai in respect of students being trained at Padmashri Dr. D.Y.Patil Medical College, Navi Mumbai because of the following facts:-

- Dr. Manohar Shah, Professor & HOD possesses academic qualification in Orthopaedics and also does not have 2 y training in Emergency Medicine. Working as faculty cannot be considered as training. Further he has been appointed as Professor of Emergency Medicine straightaway from the post of Professor of Orthopaedics without any experience in Emergency Medicine.
- 2. Dr. Deepali Rajpal, Professor possesses academic qualification in Anaesthesiology and also does not have 2 y training in Emergency Medicine. Working as faculty cannot be considered as training. Further, although it is stated that she has worked as Asso. Prof. of Emergency Medicine at MGM medical College, Navi Mumbai from 27/11/2012 to 03/01/2015, neither Experience Certificate nor Relieving Order for the same are attached; hence also this period cannot be considered. She is appointed as Asso. Prof. of Emergency Medicine from the post of Asst. Prof. of Anaesthesiology without any experience in Emergency Medicine.
- 3. Dr. Ajit Bavaskar, Asso. Prof. possesses academic qualification in Anaesthesiology and also does not have 2 y training in Emergency Medicine. Working as faculty cannot be considered as training. He is appointed as Asso. Prof. of Emergency Medicine from the post of Asso. Prof. of Anaesthesiology without any experience in Emergency Medicine.
- 4. Promotion of Dr. Deepali Rajpal, Prof., is not as per regulations. No certificate of 2 years special training has been given and experience certificate of working at MGM Navi Mumbai is not available. She was promoted in 2015 after cut off date and she has no publications.
- 5. Resultantly, none of the faculty has academic qualification in Emergency Medicine or 2 y training in Emergency Medicine.
- 6. OPD attendance upto 2 p.m. on day of assessment was only 45.
- 7. In 2016 two students and one student in 2017 has been admitted in MD(Emergency Medicine) course, in spite of MCI's letter not to admit any students without compliance. Hence, it is irregular, not in accordance with MCI regulations.
- 8. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. 2 seats after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."

Read: the Compliance Verification Assessment Report(09.02.2018) and Council Assessor's Report (June, 2015) on the standard of examination and other teaching facilities for Renewal of recognition of MD(General Medicine) qualification for 6 seats and Recognition against increased intake from 6 to 15 seats at Padmashri Dr. D.Y.Patil Medical College, Navi Mumbai granted by Padmashri Dr. D.Y. Patil University, Navi Mumbai.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (09/02/2018) along with the Council Assessor's Report (June, 2015) and compliance dated 10/05/2016 submitted by the college authorities and decided to recommend not to renew the recognition of MD(General Medicine) qualification for 6 seats and not to recognize against increased intake from 6 to 15 seats granted by Padmashri Dr. D.Y. Patil University, Navi Mumbai in respect of students being trained at Padmashri Dr. D.Y.Patil Medical College, Navi Mumbai because of the following facts:-

- Dr. D.C. Gupta, Professor is promoted as Assoc. Prof. with experience of only 1 year 2 month as Asst. Prof. against requirement of 5 years and Professor with only 1 year and 11 months experience as Assoc.Prof. against the requirement of 3/4 years; hence his promotion is not as per Regulations & he cannot be considered.
- 2. The following faculty were absent on the day of assessment:-
 - Sadanand Shetty, Professor was absent.
 - Piyush Jain, SR was absent.
 - SV Kulkarni, Astt.Prof. was absent.
 - Keyur Seth, Asstt.Prof. was absent.
- 3. Promotion of Dr. Manish Pendse, Assoc.Prof., is not as per regulations. He was promoted on 19.08.2016 after cut of date. He does not have 2 required indexed journals.
- 4. Bed Occupancy at 10 a.m. on day of assessment was 59.16 %.
- 5. On inspection of General medicine wards at 10 a.m., 42 patients were found to be having Ophthalmic complaints and were pre-operative patients from Ophthalmology.
- 6. 26 patients were found to be having complaints of Low Backache & Knee Pain and other Orthopaedic complaints.
- 7. 1 patient with BPH was admitted in General medicine ward without any sign/symptom pertaining to General Medicine.
- 8. Among other admitted patients, most were of febrile illness.
- 9. There were only 151 samples tested in OPD till 2 p.m. which is very less when compared with OPD attendance claimed by the Institute.
- 10. No physical registers are maintained.
- 11. Separate data for lab. Investigations in pathology department are not maintained.
- 12. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. 6 seats till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate

Course. This is also clarified in the letter of recognition granted u/s 11(2) of the IMC Act, 1956 issued for these seats, which reads as under:

"...the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Read: the Compliance Verification Assessment Report(22.02.2018) and Council Assessor's Report (May, 2015 26.05.2016 & 30.03.2017) on the standard of examination and other teaching facilities for Renewal of recognition of MS(OBG) and DGO qualifications for 3 seats at Padmashri Dr. D.Y.Patil Medical College, Navi Mumbai granted by Padmashri Dr. D.Y. Patil University, Navi Mumbai.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (22/02/2018) along with the Council Assessor's Report (May, 2015 26.05.2016 & 30.03.2017) and compliance dated Council received date 04/10/2017 submitted by the college authorities and decided to recommend not to renew the recognition of MS(OBG) and DGO qualifications for 3 seats each granted by Padmashri Dr. D.Y. Patil University, Navi Mumbai in respect of students being trained at Padmashri Dr. D.Y.Patil Medical College, Navi Mumbai because of the following facts:-

- 1. Promotion of Dr. Richa Singh, Prof., is not as per regulations. She was promoted on 01.1.2015 after cutoff date. She has no publication (no proof attached). Resultantly, Unit-V left with 2 faculty only.
- 2. Dr. Abhishek Chandra, Asstt.Prof. is not eligible. He is DNB from nonteaching hospital and he has no 3 years experience as Jr. Resident from a teaching hospital.

- 3. Dr. Aditi Trivedi, Sr.Resident, is not eligible. She is DNB from non-teaching hospital. She has no 3 years experience as Jr. Resident when appointed Sr.Resident.
- 4. Workload at the following speciality clinics is very low:
 - (a) Gynaec Endocrine clinic: 1-2 cases/clinic;
 - (b) Antenatal clinic: 2-3 cases/clinic;
 - (c) High Risk Pregnancy clinic: 2-3 cases/clinic;
 - (d) Cancer clinic: 4-5 cases/clinic.
- 5. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. 3 seats till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. This is also clarified in the letter of recognition granted u/s 11(2) of the IMC Act, 1956 issued for these seats, which reads as under:

"...the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

Read: letter dated 13.02.2018, Compliance dated 24.10.2017 received from college authorities and previous Assessment Report (28.04.2017 & July, 2016) on the standard of examination and other teaching facilities for Recognition of MD(Anaesthesia) qualification for 1 seat at ESI-PGIMSR, Manickatala, Kolkata granted by West Bengal University of Health Sciences, Kolkata.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (28/04/2017) along with the Council Assessor's Report (July, 2016) and compliance dated 24/10/2017 submitted by the college authorities and decided to recommend not to recognize MD(Anaesthesia) qualification for 1 seat granted by West Bengal University of Health Sciences, Kolkata in respect of students being trained at ESI-PGIMSR, Manickatala, Kolkata because of the following facts:-

- 1. Deficiency of faculty: (a) Assoc. Prof.: 1; (b) Asst. Prof.: 1.
- Promotion of Dr. Binay Kr. Biswas, Prof., is not as per regulations. He was Asst.Prof. for 3 years 5 months against the required (4 years with publications & 5 years without publications).
- 3. Dr. Shantanu Basak, Asst.Prof., was absent on the assessment day.
- 4. There were only 4 Major Operations on day of assessment.
- 5. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. 1 seat till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. This is also clarified in the letter of recognition granted u/s 11(2) of the IMC Act, 1956 issued for these seats, which reads as under:

"...the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

77. <u>Rajiv Gandhi University of Health Sciences, Bangalore - Recognition of MD(General Medicine) qualification for 06 sests in respect of students being trained at ESI-PGIMSR, ESI-Hospital, Rajajinnagar, Banglore.</u>

Read: letter dated 21.11.2017 received from Dean ESI-PGIMSR,ESI-Hospital, Rajajinnagar, Banglore and previous assessment reports (06.03.2017, 15.06.2017 and May, 2014) on the standard of examination and other teaching facilities for Recognition of MD(General Medicine) qualification for 06 sests at ESI-PGIMSR,ESI-Hospital, Rajajinnagar, Banglore granted by Rajiv Gandhi University of Health Sciences, Bangalore.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment Report (06/03/2017) along with the Council Assessor's Report (27-28.05.2014 (and 15.06.2017 for 04 to 06 seats) and compliance dated 03/07/2017 submitted by the college authorities along with the legal opinion and accepted the Legal Opinion, which is as under:

"I have perused the letter dated 21.11.17 of the ESIC Medical College regarding the issue of acceptance of Dr. J.C. Panchasheelan. The College has referred to the order dated 29.09.15 passed by the Hon'ble Central Administrative Tribunal, Bangalore wherein the Hon'ble Hon'ble CAT had allowed the prayer of Dr. J.C. Panchasheelan to be designated as Associate Professor w.e.f. the date of his actual joining to that post from 05.04.2013. The Hon'ble CAT has noted in its order that that MCI had accepted the Declaration Form of Dr. J.C. Panchasheelan during the course of assessment. The ESIC had preferred Writ Petition No. 16384/2016 – ESIC & Ors vs. Dr. J.C. Panchasheelan which had affirmed the orders of the Hon'ble CAT. The operative part of the order reads as under:-

"12. In view of the aforesaid facts and circumstances, two conclusions can be reached; One is that the respondents was already posted as Associate Professor from 05.04.2013 and he was shown as working on the said post. The second is that, respondent in any case has fulfilled the requisite criteria for regular promotion/promotion as Associate Professor from the post of Assistant Professor and he was already officiating from 05.04.2013 onwards.

13. In view of the aforesaid two conclusions, when one is officiating on the post of Associate Professor, naturally he would be entitled to the salary and other benefits accorded for the post of Associate Professor. Further when there was only on post of Associate Professor and the said post has already been filled up as back on 05.04.2013, may be by officiating initially but thereafter if the respondent is continued on the said post till the notification, he can be considered for regular posting as Associate Professor and the bar of age or qualification does not apply for consideration for promotion. As per the Recruitment Regulations, the post is to be filled up by promotion and as there was only one post , the notification so far as Associate Professor is concerned may not be required, since the post was already filled up or can be filled up by promotion to the respondent. If the aforesaid aspects are considered, we do not find that the ultimate decision taken by the Tribunal would not call for any interference.

Hence present petition is dismissed."

2. SLP (C) No. 27781/2017 – ESIC vs. Dr. J.C. Panchasheelan against the aforesaid orders of the Hon'ble High Court came to be dismissed by the Hon'ble Supreme Court on 22.09.17. In view of the above orders of the Hon'ble CAT affirmed by Hon'ble High Court of Karnataka and Hon'ble Supreme Court, the objection regarding the promotion of Dr. J.C. Pancheelan may be dropped and the matter may be further processed for grant of recognition of MD (General Medicine) qualification awarded by ESIC Medical College, Bengaluru."

In view of above, the Committee decided to recommend to the Central Government that MD(General Medicine) qualification for 06 seats granted by Rajiv Gandhi University of Health Sciences, Bangalore in respect of students being trained at ESI-PGIMSR,ESI-Hospital, Rajajinnagar, Banglore be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

78. <u>Santosh University, Ghaziabad – Recognition of MD(Forensic Medicine)</u> <u>qualification for 1 seat in respect of students being trained at Santosh Medical</u> <u>College, Ghaziabad.</u>

Read: the compliance dated 09.01.2018, Legal opinion and compliance verification assessment report (27.11.2014) and previous assessment report (20.05.2011) for Recognition of MD(Forensic Medicine) qualification for 1 seat in respect of students being trained at Santosh Medical College, Ghaziabad.

The Postgraduate Medical Education Committee considered the compliance dated 09.01.2018, Legal opinion and compliance verification assessment report (27.11.2014) and previous assessment report (20.05.2011) for Recognition of MD(Forensic Medicine) qualification for 1 seat in respect of students being trained at Santosh Medical College, Ghaziabad. After due deliberations, it was decided that the Institute be advised to submit an undertaking that no further batch will be admitted

until permission to conduct medico-legal post-mortems is granted as has been submitted by other Institutes/department similarly situated and upon submission of such an undertaking, Recognition of batches already admitted be recommended for Recognition.

The matter may be brought again after taking undertaking from the college.

79. <u>MGM Institute of Health Sciences, Navi Mumbai - Recognition of</u> <u>DM(Cardiology) qualification for 1 seat in respect of students being trained at</u> <u>Mahatma Gandhi Mission's Medical College, Aurangabad - Maharashtra</u> <u>(Trust)..</u>

Read: the Council Assessor's Report (16.02.2018) on the standard of examination and other teaching facilities for Recognition of DM(Cardiology) qualification for 1 seat in respect of students being trained at Mahatma Gandhi Mission's Medical College, Aurangabad, Maharashtra.

The Postgraduate Medical Education Committee considered the Council Assessor's Report (16.02.2018) and decided to recommend not to recognize DM(Cardiology) qualification for 1 seat granted by MGM Institute of Health Sciences, Navi Mumbai in respect of students being trained at Mahatma Gandhi Mission's Medical College, Aurangabad, Maharashtra because of the following facts:-

- 1. Workload of the following is NIL on day of assessment as well as on randomly selected days:
 - (a) Valvuloplasty/Umbrella Closure;
 - (b) PPC Implanted;
 - (c) Intra-Aortic Balloon Pump Insertion;
 - (d) Holter;
- 2. Total number of OPD patients has decreased from 6,322 to 5,489 during preceding 3 year period.
- 3. Total number of IPD patients has decreased from 6,529 to 5,663 during preceding 3 year period.
- 4. Although total number of OPD patients last year was 5,489, the number of IPD patients during the same period is shown as 5,663 which is not feasible. There is data mismatch.
- 5. Workload of the following procedures is very low during the last year:
 - (a) Holter: NIL;
 - (b) Intra-Aortic Balloon Pump Insertion: 09;
 - (c) PPC Implanted: 22;
 - (d) Valvuloplasty/Umbrella Closure: 34.
- 6. Equipment like Holter is not in working order on day of assessment as well as on randomly selected days.
- 7. Equipment like Computerized PFT are not available.
- 8. Specialty clinic like Combined clinic with CVTS department is not conducted.
- 9. In the column "Payment of stipend paid in Govt. colleges by State Govt.", it is stated that "As per Govt. of Maharashtra GR"; quantum of stipend paid is not provided and hence it is an attempt to mislead the Council. In the column "Stipend paid by Institute to Residents", it is shown as Rs. 43,413; Rs. 43,881 &Rs. 43,449 respectively to I/II/III year Residents which is less than that paid by State Govt. to Residents & is contrary to PG Regulations.
- 10. On assessment day there were only 5 MRI in the entire hospital and 7 CT Scan.
- 11. All three Sr. Residents are not registered for DM hence, they are not eligible.
- 12. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. 1 seat till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. This is also clarified in the letter of recognition granted u/s 11(2) of the IMC Act, 1956 issued for these seats, which reads as under:

"...the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."

In case, the college authorities desire to submit compliance, same should be received in this office preferably within four weeks of issue of this letter but definitely, prior to next admission so that the matter of recognition can be finally decided. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

80. Issuance of Central Government Notification of various PG qualifications – reg.

Read: the suggestion that the date of passing of first batch of the degree/diploma (which is applicable) may be mentioned in the Council letter while sending the recommendations to Central Government for Notification so that student should not suffer for want of registration.

The Postgraduate Medical Education Committee considered the suggestion that the date of passing of first batch of the degree/diploma (which is applicable) may be mentioned in the Council letter while sending the recommendations to Central Government for Notification so that student should not suffer for want of registration and decided that the existing procedure is well in order and the same should continue. We are mentioning the date of Letter of Permission when first batch was started as well as when request for recognition inspection under section 11(2) was received for the first time and examination that was inspected.

81. <u>Medical Education – Admission for PG/ Diploma Medical courses for the year</u> <u>2018-19 – Reservation of 50% seats in State quota to Service Post Graduates</u> Amendment to the PG Regulations 2000 – Regarding.

Read: the D.O. letter dated 06/03/2018 received from the Principal Secretary to Government of Tamil Nadu, Health and Family Welfare Department, Chennai with regard to reservation of 50% seats in State quota to service Postgraduates for admission for PG/Diploma Medical courses for the year 2018-19 along with the letter dated 30/12/2017 from the South Indian Government Doctor's Forum, Guntur, Andhra Pradesh.

The Postgraduate Medical Education Committee considered the D.O. letter dated 06/03/2018 received from the Principal Secretary to Government of Tamil Nadu, Health and Family Welfare Department, Chennai with regard to reservation of 50% seats in State quota to in-service doctors for admission to PG Degree/Diploma Medical courses for the year 2018-19 along with the letter dated 30/12/2017 from the South Indian Government Doctor's Forum, Guntur, Andhra Pradesh and decided that the

matter involve some judicial pronouncements, it be referred for opinion of the Learned Additional Solicitor General of India and all relevant background information be sent to him. On receipt of the opinion of the Ld. ASG, matter be resubmitted.

82. <u>Request for updating MCI website regarding the recognition status of MD(Pathology) and MS (General Surgery) courses offered at Kasturba Medical College, Mangalore – reg.</u>

Read: the letter dated 30/01/2018 received from the Registrar, Manipal Academy of Higher Education with regard to updating MCI website regarding the recognition status of MD(Pathology) and MS (General Surgery) courses offered at Kasturba Medical College, Mangalore.

The Postgraduate Medical Education Committee considered the letter dated 30/01/2018 received from the Registrar, Manipal Academy of Higher Education with regard to updating MCI website regarding the recognition status of MD(Pathology) and MS (General Surgery) courses offered at Kasturba Medical College, Mangalore and decided that the website of the MCI should be corrected as per the decision of the Postgraduate Committee, approved by the General Body of the Council and notified by the Central Govt. The Committee further decided that if there is any discrepancy, the opinion of the Law Officer be taken before correcting the website.

83. <u>Kerala University of Health Sciences, Thrissur – Recognition of</u> <u>MD(Anaesthesiology) qualification for 3 seats in respect of students being</u> <u>trained at Regional Cancer Centre, Thiruvananthapuram – Representation reg.</u>

Read: the letter dated 15/02/2018 received from the Director, Regional Cancer Centre, Thiruvananthapuram with regard to Recognition of MD(Anaesthesiology) qualification for 3 seats in respect of students being trained at Regional Cancer Centre, Thiruvananthapuram granted by Kerala University of Health Sciences, Thrissur.

The Postgraduate Medical Education Committee considered theletter dated 15/02/2018 received from the Director, Regional Cancer Centre, Thiruvananthapuram with regard to Recognition of MD(Anaesthesiology) qualification for 3 seats in respect of students being trained at Regional Cancer Centre, Thiruvananthapuram granted by Kerala University of Health Sciences, Thrissur and decided to reiterate its earlier decision.

84. <u>Starting of DM(Endocrinology) course at Medical College,</u> <u>Thiruvananthapuram under Kerala University of Health Sciences, Thrissur u/s</u> <u>10A of the IMC Act, 1956 for the academic year 2016-17 – Show cause notice</u> <u>issued u/s 8(3)(1)(d) – regarding.</u>

Read: the matter with regard to show-cause notice issued u/s 8(3)(1)(d) in respect of Starting of DM(Endocrinology) course at Medical College, Thiruvananthapuram under Kerala University of Health Sciences, Thrissur u/s 10A of the IMC Act, 1956 for the academic year 2016-17 along with the observations of the Ethics Committee.

The Postgraduate Medical Education Committee considered the matter with regard to show-cause notice issued u/s 8(3)(1)(d) in respect of Starting of DM(Endocrinology) course at Medical College, Thiruvananthapuram under Kerala University of Health Sciences, Thrissur u/s 10A of the IMC Act, 1956 for the academic

year 2016-17 along with the observations of the Ethics Committee and noted the observations of the Ethics Committee of the Council.

85. <u>Recognition of D.Ortho. qualification for 01 seat in respect of students being</u> <u>trained at Mahatma Gandhi Mission's Medical College, Aurangabad under</u> <u>MGM Institute of Health Sciences, Navi Mumbai – reg.</u>

Read: the letter dated 20/02/2018 received from the Government of India, Ministry of Health & Family Welfare, New Delhi and letter dated 20/02/2018 received from Dr. Abhishek K. Singh and Dr. Mayank K Patel with regard to Recognition of D.Ortho. qualification for 01 seat in respect of students being trained at Mahatma Gandhi Mission's Medical College, Aurangabad under MGM Institute of Health Sciences, Navi Mumbai.

The Postgraduate Medical Education Committee considered the letter dated 20/02/2018 received from the Government of India, Ministry of Health & Family Welfare, New Delhi and letter dated 20/02/2018 received from Dr. Abhishek K. Singh and Dr. Mayank K Patel with regard to Recognition of D.Ortho. qualification for 01 seat in respect of students being trained at Mahatma Gandhi Mission's Medical College, Aurangabad under MGM Institute of Health Sciences, Navi Mumbai decided that the course should be recognized from the year 2013 when the first batch appeared in the examination since the institution had applied for inspection under section 11(2) of the IMC Act in 2013 in –time.

Any Other matter

The Postgraduate Committee noted that the Council Office received the Central Government letter dated 12.03.2018 and similar other requests from the individual Colleges/Central Govt. with regard to not granting one time increase in postgraduate courses at certain Govt. Medical Colleges. The Committee decided to convey the reasons as recorded for not recommending increase of seats.
