**1. Minutes of the last meeting of the Postgraduate Medical Education Committee – confirmation of.**

The Postgraduate Medical Education Committee confirmed the minutes of the Postgraduate Medical Education Committee meeting held on 26.06.2018.

Postgraduate Medical Education Committee observed that the recommendations of the meeting dated 12.06.2018 against item no.58. were for renewal of recognition and not for recognition. Hence, the decision be read corrected as under:-

**58. Maharashtra University of Health Sciences, Nashik - Renewal of recognition of DM (Clinical Haematology) qualification for 2 seats in respect of students being trained at Seth G.S. Medical College & King Edward VII Memorial Hospital, Parel Mumbai..**

*"The Postgraduate Medical Education Committee considered the Council Assessor's Report (August, 2017) and decided to recommend to the Central Government that the recognition of DM (Clinical Haematology) qualification for 2 seats granted by Maharashtra University of Health Sciences, Nashik in respect of students being trained at Seth G.S. Medical College & King Edward VII Memorial Hospital, Parel Mumbai be renewed.*

*The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."*

**56. Kerala University of Health Sciences, Thrissur - Recognition of MD(Radiodiagnosis) qualification for 1 seat in respect of students being trained at Academy of Medical Sciences, Pariyaram, Kannur..**

Read: the Compliance Verification Assessment report (07/06/2018) along with the Council Assessor's Reports (23.03.2017), (May, 2016) & (July, 2015) and alongwith Interim Order dated 30.05.2018 passed by the Hon'ble High Court of Kerala on the standard of examination and other teaching facilities for Recognition of MD(Radio-diagnosis) qualification for 01 seats at Academy of Medical Sciences, Pariyaram, Kannur.

The Postgraduate Medical Education Committee considered the Compliance Verification Assessment report (07/06/2018) along with the Council Assessor's Reports (23.03.2017), (May, 2016) & (July, 2015) and alongwith Interim Order dated 30.05.2018 passed by the Hon'ble High Court of Kerala and decided to recommend to the Central Government that MD(Radio-diagnosis) qualification for 01 seats granted by Kerala University of Health Sciences, Thrissur in respect of students being trained at Academy of Medical Sciences, Pariyaram, Kannur be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**57. Vinayaka Missions University (Deemed), Salem, Tamil Nadu- Renewal of recognition of MS(Ophthalmology) qualification for 2 seats in respect of students being trained at Vinayaka Mission's Kirupananda Variyar Medical College, Salem, Tamil Nadu.**

Read: the Assessment Report (10.05.2018) on the standard of examination and other teaching facilities available at Vinayaka Mission's Kirupananda Variyar Medical College, Salem, Tamil Nadu for purpose of Renewal of recognition of MS(Ophthalmology) qualification for 2 seats granted by Vinayaka Missions University (Deemed), Salem, Tamil Nadu.

The Postgraduate Medical Education Committee considered the Assessment Report (10.05.2018) and decided to recommend to the Central Government that the recognition of MS(Ophthalmology) qualification for 2 seats granted by Vinayaka Missions University (Deemed), Salem, Tamil Nadu in respect of students being trained at Vinayaka Mission's Kirupananda Variyar Medical College, Salem, Tamil Nadu be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. **58. Vinayaka Missions University (Deemed), Salem, Tamil Nadu- Renewal of recognition of MS(Orthopaedics) qualification for 2 seats in respect of students being trained at Vinayaka Mission's Kirupananda Variyar Medical College, Salem, Tamil Nadu.**

Read: the Assessment Report (10.05.2018) on the standard of examination and other teaching facilities available at Vinayaka Mission's Kirupananda Variyar Medical College, Salem, Tamil Nadu for purpose of Renewal of recognition of MS(Orthopaedics) qualification for 2 seats granted by Vinayaka Missions University (Deemed), Salem, Tamil Nadu.

The Postgraduate Medical Education Committee considered the Assessment Report (10.05.2018) and decided to recommend to the Central Government that the recognition of MS(Orthopaedics) qualification for 2 seats granted by Vinayaka Missions University (Deemed), Salem, Tamil Nadu in respect of students being trained at Vinayaka Mission's Kirupananda Variyar Medical College, Salem, Tamil Nadu be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.



**59. Vinayaka Missions University (Deemed), Salem, Tamil Nadu- Renewal of recognition of MD(Paediatrics) qualification for 2 seats in respect of students being trained at Vinayaka Mission's Kirupananda Variyar Medical College, Salem, Tamil Nadu.**

Read: the Assessment Report (09.05.2018) on the standard of examination and other teaching facilities available at Vinayaka Mission's Kirupananda Variyar Medical College, Salem, Tamil Nadu for purpose of Renewal of recognition of MD(Paediatrics) qualification for 2 seats granted by Vinayaka Missions University (Deemed), Salem, Tamil Nadu.

The Postgraduate Medical Education Committee considered the Assessment Report (09.05.2018) and decided to recommend not to renew the recognition of MD(Paediatrics) qualification for 2 seats granted by Vinayaka Missions University (Deemed), Salem, Tamil Nadu in respect of students being trained at Vinayaka Mission's Kirupananda Variyar Medical College, Salem, Tamil Nadu because of the following facts:-

1. Attendance at several Specialty clinics is low: 2-3 cases/clinic.
2. Equipment like Transport Incubator are not available.
3. There is only 1 publication from the department during last 3 years.
4. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. 2 till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. This is also clarified in the letter of recognition granted u/s 11(2) of the IMC Act, 1956 issued for these seats, which reads as under:

*"...the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."*

Read: the Assessment Report (11.05.2018) on the standard of examination and other teaching facilities available at Vinayaka Mission's Kirupananda Variyar Medical College, Salem, Tamil Nadu for purpose of Renewal of recognition of MD/MS(OBG) qualification for 2 seats granted by Vinayaka Missions University (Deemed), Salem, Tamil Nadu.

The Postgraduate Medical Education Committee considered the Assessment Report (11.05.2018) and decided to recommend not to renew the recognition of MD/MS(OBG) qualification for 2 seats granted by Vinayaka Missions University (Deemed), Salem, Tamil Nadu in respect of students being trained at Vinayaka Mission's Kirupananda Variyar Medical College, Salem, Tamil Nadu because of the following facts:-

1. There was NIL Caesarean Section on day of assessment.
2. Separate data for Obstetrics & Gynaecology clinical material are not provided.
3. Attendance at Specialty clinic like Gynaec Endocrine clinic, Cancer clinic, Family Planning clinic, Adolescent clinic is low: 2-3 / 4-5 cases/clinic.
4. ART is not available.
5. Total number of Major Operations has decreased from 644 in 2015 to 587 in 2017.
6. Total number of Minor Operations has decreased from 826 in 2015 to 530 in 2017.
7. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. 2 till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. This is also clarified in the letter of recognition granted u/s 11(2) of the IMC Act, 1956 issued for these seats, which reads as under:

*"...the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Read: the Assessment Report (23.05.2018) on the standard of examination and other teaching facilities available at Jorhat Medical College & Hospital, Jorhat for purpose of Recognition of MD(Physiology) qualification for 3 seats granted by Srimanta Sankaradeva University of Health Sciences, Assam.

The Postgraduate Medical Education Committee considered the Assessment Report (23.05.2018) and decided to recommend not to recognize MD(Physiology) qualification for 3 seats granted by Srimanta Sankaradeva University of Health Sciences, Assam in respect of students being trained at Jorhat Medical College & Hospital, Jorhat because of the following facts:-

1. There is no Professor.
1. Equipment like EMG (4-8 channels) are not functional.
2. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. 3 after the first batch appeared in Examination till their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

*"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."*

In case, the college authorities desire to submit compliance, same should be received in this office within 30 days from the date of communication of the deficiencies by the Council as specified in the Gazette Notification dated 05.11.2018. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

**62. The Tamil Nadu Dr. M.G.R. Medical College University, Chennai- Renewal of recognition of MD(Pathology) qualification for 7 seats in respect of students being trained at Tirunelveli Medical College, Tirunelveli.**

Read: the Assessment Report (23rd May, 2018) on the standard of examination and other teaching facilities available at Tirunelveli Medical College, Tirunelveli for purpose of Renewal of recognition of MD(Pathology) qualification for 7 seats granted by The Tamil Nadu Dr. M.G.R. Medical College University, Chennai.

The Postgraduate Medical Education Committee considered the Assessment Report (23rd May, 2018) and decided to recommend not to renew the recognition of MD(Pathology) qualification for 7 seats granted by The Tamil Nadu Dr. M.G.R. Medical College University, Chennai in respect of students being trained at Tirunelveli Medical College, Tirunelveli because of the following facts:-

1. Dr. K. Swaminathan is shown as "Professor" in the column of "Designation" in the faculty table; however in the column of "Experience", it is shown as "Asso. Prof." w.e.f. 12/10/2004 till date. No explanation is provided for this dichotomy.
2. Workload of CT guided FNAC was only 32 in 2017.
3. Workload of USG guided FNAC was only 74 in 2017.
4. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. 7 till renewal of their recognition will be irregular/ illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely renewal of recognition as required shall invariably result in stoppage of admissions to the concerned Post Graduate Course. This is also clarified in the letter of recognition granted u/s 11(2) of the IMC Act, 1956 issued for these seats, which reads as under:

*"...the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course."*

Read: the Assessment Report (19.05.2018) on the standard of examination and other teaching facilities available at Shri Guru Ram Rai Institute of Medical & Health Sciences, Dehradun for purpose of Recognition of MS(Orthopaedics) qualification for 2 seats granted by H. N. B Garhwal University, Uttarakhand.

The Postgraduate Medical Education Committee considered the assessment Report (19.05.2018) and decided to recommend to the Central Government that MS(Orthopaedics) qualification for 2 seats granted by H. N. B Garhwal University, Uttarakhand in respect of students being trained at Shri Guru Ram Rai Institute of Medical & Health Sciences, Dehradun be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**64. SRM University, Chennai, Tamil Nadu- Recognition of MS(Ophthalmology) qualification against increased intake from 2 to 3 seats in respect of students being trained at SRM Medical College Hospital & Research Centre, Kancheepuram, Tamil Nadu.**

Read: the Assessment Report (12.05.2018) on the standard of examination and other teaching facilities available at SRM Medical College Hospital & Research Centre, Kancheepuram, Tamil Nadu for purpose of Recognition of MS(Ophthalmology) qualification against increased intake from 2 to 3 seats granted by SRM University, Chennai, Tamil Nadu.

The Postgraduate Medical Education Committee considered the Assessment Report (12.05.2018) and decided to recommend to the Central Government that MS(Ophthalmology) qualification against increased intake from 2 to 3 seats granted by SRM University, Chennai, Tamil Nadu in respect of students being trained at SRM Medical College Hospital & Research Centre, Kancheepuram, Tamil Nadu be recognized and included in the 1st Schedule to the I.M.C. Act, 1956.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.



**65. The Tamilnadu Dr. MGR Medical University, Chennai- Renewal of Recognition of MS(General Surgery) qualification for 4 seats in respect of students being trained at PSG Institute of Medical Sciences & Research, Coimbatore.**

Read: the assessment Report (24.05.2018) on the standard of examination and other teaching facilities available at PSG Institute of Medical Sciences & Research, Coimbatore for purpose of Renewal of Recognition of MS(General Surgery) qualification for 4 seats granted by The Tamilnadu Dr. MGR Medical University, Chennai.

The Postgraduate Medical Education Committee considered the assessment Report (24.05.2018) and decided to recommend to the Central Government that the recognition of MS(General Surgery) qualification for 4 seats granted by The Tamilnadu Dr. MGR Medical University, Chennai in respect of students being trained at PSG Institute of Medical Sciences & Research, Coimbatore be renewed.

The Postgraduate Medical Education Committee further decided that the recognition so granted shall be for a maximum period of 5 years from the date of Notification upon which the Institute shall have to apply for renewal of recognition. Failure to seek timely renewal of recognition as required shall invariably result in stoppage of admission to the Postgraduate Course.

**66. Srimanta Shankardeva University of Health Sciences- Recognition of MD(Psychiatry) qualification against increased intake from 4 to 5 seats in respect of students being trained at Gauhati Medical College, Guwahati.**

Read: the Assessment Report (21.05.2018) on the standard of examination and other teaching facilities available at Gauhati Medical College, Guwahati for purpose of Recognition of MD(Psychiatry) qualification against increased intake from 4 to 5 seats granted by Srimanta Shankardeva University of Health Sciences.

The Postgraduate Medical Education Committee considered the Assessment Report (21.05.2018) and decided to recommend not to recognize MD(Psychiatry) qualification against increased intake from 4 to 5 seats granted by Srimanta Shankardeva University of Health Sciences in respect of students being trained at Gauhati Medical College, Guwahati because of the following facts:-

1. HOD is Dr. Deepanjali Medhi who is only Assoc. Prof.
2. Unit I which is headed by sole Professor available and has no Assoc. Prof.; resultantly faculty complement is incomplete & it cannot be considered as PG unit.
3. There is no person with Designation of Senior Resident. Designations like Registrar, Resident Physician are not commensurate with those prescribed under the Regulations.
4. Bed Occupancy at 10 a.m. on day of assessment was 66.66 %.
5. Average OPD of randomly selected days is only 42.
6. Chronic Psychiatry care facility is not available.
7. Total number of IPD patients has decreased from 748 to 634 during preceding 3 year period.
8. Other deficiencies as pointed out in the assessment report.

Admissions done (if any) against these seats i.e. increased intake from 4 to 5 seats after the first batch appeared in Examination till their recognition will be irregular/illegal and not in accordance with MCI regulations (notified with prior permission of Central Government vide notification dated 21/07/2009) and will not be recognized. As

per provisions of the Postgraduate Medical Education Regulations, 2000, failure to seek timely recognition as required shall invariably result in stoppage of admission to the concerned Post Graduate Course. This is also clarified in the letter of permission granted u/s 10A of the IMC Act, 1956 issued for these seats, which reads as under:

*"This permission for starting/ increase of seats in the above course and admission of students will be till such time the first batch of students admitted against the above course appears for the first final examination in the subject."*

In case, the college authorities desire to submit compliance, same should be received in this office within 30 days from the date of communication of the deficiencies by the Council as specified in the Gazette Notification dated 05.11.2018. If no compliance is received within this period or compliance/ compliance verification is found unsatisfactory, it will result in stoppage of admission to the postgraduate course against the above mentioned seats.

5. In the column "Stipend paid by the Institution", it is stated "NIL". It needs to be clarified whether any stipend is being paid to PG Residents & if so, at what rates.
6. Other deficiencies as pointed out in the assessment report.
