OFFICE ORDER

In supersession of earlier office orders of even numbers regarding nomination of CPIOs and Appellate Authorities in NMC, it has been decided with the approval of the Competent Authority that henceforth, the following shall be the system for disposal of RTIs under RTI Act, 2005, at the level of the **Central Public Information Officers (CPIOs) and First Appellate Authorities (FAAs) for different Divisions/Sections in NMC Hqrs and Boards:**

- i) There shall be 'designation-wise' separate CPIOs at US/SO level and First Appellate Authorities (FAAs) at DS/Director level for different sections/divisions of NMC Hqrs and Boards.
- (ii) In the absence of Under Secretary (CPIO) concerned either on the account of vacancy or training/long leave etc., **the Section Officer of the concerned Section/Board will be the CPIO automatically.**
- (iii) The **Link Officers of Dir./DS** concerned will work as FAA in the absence on account of long leave/training for smooth disposal of First Appeals.
