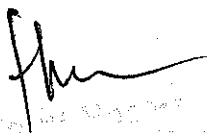
**W.P.(C) No.6970/2017**

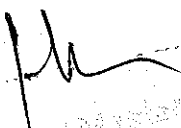
Medical Education, 1997 contending that the same is *ultra vires* of the provisions of the Constitution of India.

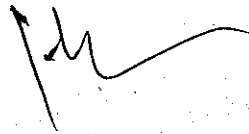
