CIRCULAR

Subject: Engagement of a retired Government Officer as Consultant (Engineering & Maintenance) on full time contract basis in National Medical Commission - inviting applications thereof- reg.

National Medical Commission, invites applications from eligible and desirous candidates retired from Centre/State/PSUs/Autonomous bodies, etc., having considerable experience of functioning of Government/ Ministries/Departments/ Autonomous Bodies/ PSUs, for engagement as Consultant (Engineering and Maintenance) on contractual full time basis having experience in **Civil Engineering** works.

2. The number of vacancy is 01 (one). Details of required Consultant to be engaged are as under:

A. Eligibility Conditions

1. BE/B.Tech or Equivalent or Diploma in Civil/Electrical/Mechanical Engineering.
2. Retired Government Officer from Central/State Government/ Autonomous Bodies/ CPSUs/ PSUs at Level-11 (PB-3/GP 6600) or above or equivalent having civil engineering, maintenance or infrastructure-related experience.
3. Desirable Experience / Preference:
 - Atleast 10 years of relevant experience in Civil Engineering works, maintenance of office buildings/institutions, Preventive and corrective maintenance systems. Additional experience of mechanical & electrical works is desirable.
 - Preference will be given to candidates who have served in CPSUs/PSUs engaged in civil/electrical/infrastructure construction and maintenance, such as NBCC, NPCC, EIL, HUDCO, State Engineering / PWD Departments etc.

B. Job Profile (Indicative and Not Exhaustive)

The Consultant (Engineering & Maintenance) shall be responsible for:

1. Overall supervision and monitoring of all civil infrastructure-related works of NMC.
2. Supervision of electrical/mechanical works in NMC.
3. Coordination with CPWD, vendors, contractors, or executing agencies regarding ongoing and planned works.
4. Conducting regular inspections of the building for identifying issues such as leaks, seepage, structural defects, electrical faults, safety hazards, etc.
5. Advising on repairs, renovation, upgradation, and preparing technical reports, inspection notes, deficiency lists, and recommendations for improvement.
6. Assisting the Administration in planning, budgeting, and prioritization of maintenance works.
7. Any other engineering/technical responsibility assigned by the competent authority.

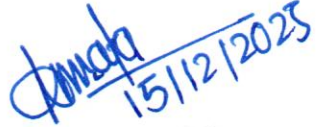
3. **General Conditions for the post:**

- i. **Period of engagement:** initially for a period of one year which is extendable for further period(s) subject to satisfactory performance.
- ii. **Location:** National Medical Commission, Pocket-14, Sector-8, Dwarka Phase-I, New Delhi-110077
- iii. **Age:** Age should be **less than 64 years** as on **closing date of this circular**.
- iv. **Remuneration:** Last pay drawn minus pension plus transport allowance in accordance with the instructions of Government of India issued from time to time. Selected Candidate will be entitled to Transport Allowance that he/she was getting at the time of retirement/ superannuation on the Last Pay Drawn without DA. Retired Govt. Officers engaged as Consultants may be allowed TA/DA on official tour, if any, as per their entitlement at the time of retirement.
