MCI will provide original documents of the vehicle, registration certificate, insurance cover , if any and any copy of other relevant paper/s and signed RTO papers for the purpose of transfer of vehicle. However, entire process of transfer of the said vehicle to my name shall be completed by me at my own level and my own cost, within a maximum period of three months from the date of handing over possession of the vehicle by MCI to me.
5. MCI financial and legal liability with respect / due to use of the vehicle shall cease with effect from the date of handing over possession of the vehicle to me.

4. Vehicle may be inspected from 21.08.2020 to 27.08.2020 between 02.00 PM to 4.30 PM at the address given above.
5. Duly completed tender document shall be submitted to our office at the address given above on or before 27.08.2020 by 2.30 PM.
6. Application not in the prescribed format is liable for rejection.
7. Tender without EMD (@Rs. 10,000/- each car) will be rejected.
8. Tenders will be opened on 27.08.2020 at 3.00 PM
9. MCI reserves the rights to reject any or all of the tenders without assigning any reason thereof. The tenderers should have valid photo ID proof and address proof.
10. Successful tenderers will have to pay full amount of the bid amount by way of DD favouring "Secretary Medical Council of India" within three days from the date of information from MCI and take possession of the vehicle.
